# **II. Opening Comments**

## a. Public Safety Commissioners

- Commissioner Fowler: Shared background as a minister at Second Baptist Downtown, connection to violence intervention work via spouse, and desire to serve the community.
- Commissioner Lopez: Shared EMS background, personal experience with violent crime, and motivation to serve on the Commission.

- Lynette Perez, Chief Deputy City Attorney, introduced herself for the sake of the new commissioners and explained:
  - FOIA compliance procedures.
  - Support offered by City Attorney's Office.
  - Distribution of videos on FOIA and Robert's Rules of Order.
- · Commissioner Morshedi -
- National Gun Violence Awareness Day / Wear Orange Day:
  - Scheduled for Saturday, June 7, from 2–4 PM at the Awareness Center, 900 South Pine.
  - Hosted by Moms Demand Action with partner organizations in attendance.
  - Commissioners encouraged to attend and promote.

    Discussion followed about highlighting this event in future meetings and partnering with vendors in attendance.
- b. **Staff Liaison** Christopher Harvey, Senior Advisor to the Mayor
  - Mr. Harvey previewed upcoming Safe Summer Stronger City initiative.
  - Multi-department collaboration (LRPD, FIRE, Parks, 911, Zoo, Housing, etc.)
  - Events and youth engagement activities throughout the summer.
  - Website launch forthcoming.
  - Job Fair for youth (ages 16–21) scheduled for June 5.
  - Related to summer employment under "Career Climb."

## **III. Previous Meeting Follow-Up**

- a. April Meeting lacked quorum. No votes taken. Discussion of March 2024 Meeting Minutes:
  - Motion to adopt minutes by Commissioner Burris, Seconded by Commissioner Doyle: Passed unanimously.
- b. Review of draft letter addressed to LRSD Superintendent and Boys & Girls Club:
  - Regarding unsafe walking conditions for students near Wakefield Elementary.
  - Motion to approve and send letter by Commissioner Herts, Seconded by Commissioner Burris: Passed unanimously.
  - Commissioners' names to be added; official letter to be sent on city letterhead.
  - A copy will also be shared with Boys & Girls Club and Ms. Dawn Jeffries (original citizen concern).
  - Discussion on potential collaboration with Wakefield PTA and local school board member.

# On behalf of Chief Helton - Police Department Update

- a. Laura Martin (LRPD) reported:
  - Launch of specialized squad to prevent car caravanning activity.
  - Emphasis on proactive monitoring of common gathering areas.

Mark Edwards (LRPD) extended offer to provide commission members a tour of the Real-Time Crime Center.

Commissioners encouraged to do ride-alongs and stay engaged with LRPD efforts.

Summary: LRPD is preparing summer patrols to curb illegal car gatherings.

Discussion: Emphasis on proactive engagement, with offers for tours and ride-alongs.

## III. Citizen Communication - none present

## **IV. New Business**
