NARRATIVE

OFFICERS RESPONDED TO 4220 SOUTH UNIVERSITY AVENUE IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL. CONTACT WAS MADE WITH RUSTON BRACK WHO ADVISED HE WAS BEAT UP BY TWO BLACK MALES IN THE WOODED AREA BEHIND MURRAY'S DINNER PLAYHOUSE AND THE LISTED ITEMS WERE TAKEN FROM HIM. MR. BRACK DID NOT KNOW A CLOTHING DESCRIPTION OF EITHER MALE AND ONLY GAVE A NAME OF 'GATOR' FOR ONE OF THE MALES. MR. BRACK HAD FRESH BLOOD COMING FROM HIS NOSE AND BRUISING ON HIS FACE BUT HE REFUSED MEDICAL ATTENTION. OFFICERS RESPONDED TO THE WOODED AREA AND MADE CONTACT WITH SEVERAL BLACK MALE SUBJECTS WHO DENIED BEING CALLED 'GATOR'. GADDIUS REDDEN WAS AMONG THEM AND ADVISED A WHITE MALE FITTING MR. BRACK'S DESCRIPTION CAME TO THEIR CAMP CAUSING A DISTURBANCE AND WAS ASKED TO LEAVE. HE DENIED ANY PHYSICAL ALTERCATION AND DENIED TAKING MR. BRACK'S PROPERTY.

WITNESS STACY MARTIN ADVISED MR. BRACK WAS THROWING BRICKS AT MR. REDDEN AT A DIFFERENT CAMPSITE WHICH CAUSED THE DISTURBANCE BETWEEN THEM. MR. REDDEN VERBALLY CONFIRMED MS. MARTIN'S STATEMENT AND REFUSED TO PRESS CHARGES. MR. REDDEN ADVISED NONE OF THE BRICKS HIT HIM. MS. MARTIN ADVISED SHE GAVE MR. BRACK'S A BLACK DUFFEL BAG CONTAINING SEVERAL TOOLS, A LEMONADE, AND A YELLOW RAINCOAT PRIOR TO HIM LEAVING THE CAMP BEHIND MURRAY'S DINNER PLAYHOUSE. MS. MARTIN ADVISED MR. BRACK KEPT UP A VERBAL DISTURBANCE AS HE WALKED AWAY WITH THE ITEMS. MR. BRACK WAS DRIVEN TO THE CAMPSITE BUT ADVISED HE COULD NOT IDENTIFY ANY OF THE BLACK MALES THERE AS THE ONES TO HE FOUGHT WITH. ALL PARTIES WERE ENCOURAGED TO STAY AWAY FROM EACH OTHER AND TO CALL POLICE AS NEEDED.

NARRATIVE

I RESPONDED TO A SHOTS FIRED CALL AT 10 YORK DRIVE. UPON ARRIVAL, I MADE CONTACT WITH LEATRICE JOHNSON. MS. JOHNSON ADVISED IT SOUNDED LIKE SOMEONE HAD SHOT A BUNCH OF ROUNDS BESIDE HER HOUSE. OFFICERS SEARCHED THE EXTERIOR OF THE HOME AND DID NOT OBSERVE ANY BULLET HOLES. AFTER OFFICERS LEFT, APPROXIMATELY 10 MINUTES LATER, MS. JOHNSON CALLED BACK AND ADVISED SHE LOCATED MULTIPLE BULLET HOLES IN HER HOME. I RESPONDED BACK TO THIS LOCATION AND MADE CONTACT WITH MS. JOHNSON AGAIN. SHE ADVISED A WHITE CAR HAD SHOT UP THE HOUSE UP THE STREET FROM HER. I IDENTIFIED THE ADDRESS AS 4 YORK DRIVE AND MADE CONTACT WITH KIMBERLY GASCA, ELMER LOPEZ, APOLINADO DIEGO LUX, SERGIO PIEGA-LOPEZ, AND ALBERTO ORTEZ. THEY ADVISED A WHITE CAR WAS PARKED AT THE INTERSECTION OF PORTSMOUTH DR AND YORK DRIVE FIRED ROUNDS TOWARDS 4 YORK DRIVE AND 10 YORK DRIVE. THEY ADVISED THEY WERE SCARED AND DUNKED DOWN ON THE FLOOR. THEY ADVISED THE WHITE CAR LEFT THE AREA BUT DID NOT SEE THE SHOOTER OR ANY PERSON IN THE CAR. I OBSERVED THREE ROUNDS THAT CAME THROUGH THE LIVING ROOM WALL. NO FRAGMENTS WERE LOCATED. WHILE SEARCHING THE AREA FOR CASINGS, THE RESIDENT OF 3 YORK DRIVE, HUGO TEC-POP APPROACHED OFFICERS ADVISING HE HAD VIDEO OF THE INCIDENT AND SHARED IT WITH OFFICERS. I WAS ABLE TO SEE A WHITE CAR PULL INTO THE INTERSECTION OF PORTSMOUTH DR AND YORK DRIVE. THE CAR STOPPED AND APPROXIMATELY 3-5 MINUTES LATER, FIRED 10 ROUNDS FROM THE DRIVERS SIDE OF THE VEHICLE. NO SHELL CASINGS WERE LOCATED AT THE INTERSECTION. ONE SHELL CASING WAS LOCATED IN THE ROAD IN-FRONT OF 4 YORK DRIVE. IT WAS RECOVERED BY THE CSSU. WHILE ON SCENE, AN ANONYMOUS CALLER STATED TWO PEOPLE WENT INTO THE BACK YARD OF 23 PORTSMOUTH DR. OFFICERS SEARCHED THE BACK YARD AND DID NOT LOCATE ANYONE. OFFICERS WERE ABLE TO OBSERVE 2 BULLET HOLES IN THE FRONT OF THE HOUSE AND MADE CONTACT WITH TOMMIE SKINNER AND FAREEDAH MUHAMMAD WHO ADVISED THE HOLES ARE PROBABLY NEW BUT WERE UNSURE. THEY ADVISED THEIR HOUSE WAS SHOT AS WELL. NOTHING WAS OBSERVED INSIDE THE HOME. SERGEANT HUTCHINSON WAS CALLED TO THE SCENE AND A MAJOR CRIMES (GUN) DETECTIVE WAS CONTACTED AND RESPONDED TO THE SCENE. ALL PARTIES WERE PROVIDED THE INCIDENT NUMBER AND ADVISED TO CONTACT POLICE SHOULD THEY NEED FURTHER ASSISTANCE. MEDICAL WAS REFUSED BY ALL INVOLVED AND NONE HAD ANY INJURIES.
