NARRATIVE

ON 09/08/2025 OFFICERS RESPONDED TO THE LISTED LOCATION FOR A BATTERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH CIERA DIXON.

MS. DIXON ADVISED HER EX-BOYFRIEND (TIMOTHY JONES) ASSAULTED HER AND TOOK HER PHONE FROM HER. SHE ADVISED THEY GOT INTO AN ALTERCATION, AND HE THREW SOME OF HER BELONGINGS OUTSIDE. SHE ADVISED SHE THEN WALKED AWAY FROM THE LOCATION AND MR. JONES BEGAN TO FOLLOW HER, CAUSING HER TO CALL THE LRPD. MS. DIXON ADVISED ONCE MR. JONES REALIZED SHE CALLED THE POLICE HE ATTACKED HER. OFFICERS OBSERVED MS. DIXON TO HAVE SOME BRUISING ON HER BOTTOM LIP AND SOME EYE SWELLING. MS. DIXON ADVISED HE WENT THROUGH HER BAG TAKING HER PHONE AND HOUSE KEY WITH HIM AFTERWARDS. OFFICERS CIRCULATED THE AREA AND WERE UNABLE TO FIND HIM. MS. DIXON DECLINED MEDICAL ATTENTION ON SCENE.

MS. DIXON ADVISED SHE WAS TEMPORARILY LIVING AT 9808 SURREY DR. WITH MR. JONES MOTHER (VANQUESHA GRANT). MS. DIXON ADVISED MR. JONES DID NOT LIVE THERE. MS. DIXON ALSO ADVISED HER AND MR. JONES ARE NOT IN A RELATIONSHIP, BUT THEY DO HAVE A CHILD TOGETHER.

OFFICERS TRANSPORTED MS. DIXON BACK TO 9808 SURREY DR. TO COLLECT SOME PROPERTY. OFFICERS ATTEMPTED TO MAKE CONTACT WITH VANQUESHA GRANT WHO RESIDES THERE. MS. GRANT HAD LEFT THE RESIDENCE PRIOR TO OFFICERS ARRIVING. MS. DIXON COLLECTED HER PROPERTY AND ADVISED HER INFANT DAUGHTER WAS INSIDE. OFFICERS CONTACTED MS. GRANT WHO IS THE INFANT'S GRANDMOTHER VIA CELLPHONE. MS. GRANT ADVISED SHE HAD THE INFANT AND EVERYTHING WAS OKAY. MS. DIXON ADVISED SHE WAS OKAY WITH MS. GRANT TAKING CARE OF HER DAUGHTER. OFFICERS THEN TRANSPORTED MS. DIXON TO THE NORTHWEST SUBSTATION TO WAIT FOR A LYFT DRIVER.

OFFICERS CONDUCTED A BROADCAST FOR MR. JONES. OFFICERS PERFORMED A LETHALITY ASSESSMENT AND PROVIDED MS. DIXON WITH A LAURA'S CARD. 3L35 WAS NOTIFIED OF THE SITUATION.
