NARRATIVE

ON WEDNESDAY AUGUST 20TH 2025 AT APPROXIMATELY 1454 HOURS OFFICERS RESPONDED TO 700 EAST 17TH STREET FOR A DISTURBANCE WITH A WEAPON CALL FOR SERVICE. UPON ARRIVAL, OFFICERS LOCATED MICHELLE BUTLER APPARENTLY DECEASED FROM MULTIPLE INJURIES AND APPARENT GUNSHOT WOUNDS. OFFICERS SECURED THE SCENE AND CALLED FOR HOMICIDE DETECTIVES AND CSSU. HOMICIDE DETECTIVES RESPONDED TO THE SCENE AND BEGAN THE PRELIMINARY INVESTIGATION. CSSU RESPONDED AND PROCESSED THE SCENE. A SUSPECT VEHICLE DESCRIPTION WAS BROADCASTED AND SOUTHWEST PATROL OFFICERS LOCATED VEHICLE 1 AND THE SUSPECT, DUANE NOONER AT 8000 GEYER SPRINGS ROAD. A SHORT FOOT PURSUIT ENSUED, BUT MR. NOONER WAS ULTIMATELY TAKEN INTO CUSTODY. MR. NOONER WAS TRANSPORTED TO MAJOR CRIMES FOR FURTHER INVESTIGATION, AND VEHICLE 1 WAS TOWED TO THE CRIME SCENE BAY PENDING A SEARCH WARRANT FOR PROCESSING. AFTER FURTHER INVESTIGATION MR. NOONER WAS CHARGED WITH CAPITAL MURDER AND TRANSPORTED TO PULASKI COUNTY REGIONAL DETENTION FACILITY TO BE BOOKED ON THE AFOREMENTIONED CHARGE.
