**NARRATIVE**

ON SEPTEMBER 10, 2025, OFFICERS WERE DISPATCHED TO 8011 GEYER SPRINGS ROAD DUE TO A ROBBERY OF AN INDIVIDUAL CALL. UPON ARRIVAL, I WAS FLAGGED DOWN BY TWO HISPANIC MALES, WHICH ONLY SPOKE SPANISH. THEY WERE LATER IDENTIFIED AS BISMARCK (VICTIM ONE) AND JOSEPH (VICTIM TWO). BISMARCK STATED THEY WERE WALKING HOME AND CROSSED THROUGH THE PARKING LOT OF 8211 GEYER SPRINGS ROAD. THEY STATED TWO BLACK MALES BEGAN SCREAMING AT THEM FROM THE BALCONY. THE TWO MALES RAN DOWN TOWARD THEM AND KEPT YELLING ABOUT "MOTA." JOSEPH GRABBED HIS PHONE IN AN ATTEMPT TO TRANSLATE WHAT THE MALES WERE SAYING. BISMARCK STATED ONE OF THE MALES, LATER IDENTIFIED AS MR. HAMPTON (SUSPECT ONE), ALL OF A SUDDEN STRUCK HIM ON THE FACE WITH A CLOSED FIST. BISMARCK STATED MR. HAMPTON AND SUSPECT TWO STRUCK HIM MULTIPLE TIMES ON THE FACE WITH CLOSED FISTS AND THEN TOOK HIS PROPERTY. JOSEPH STATED THE SUSPECTS STRUCK HIM WITH CLOSED FISTS MULTIPLE TIMES TOO. BISMARCK STATED MR. HAMPTON PULLED OUT A SMALL BLACK PISTOL AND POINTED IT AT HIM. THE LISTED PROPERTY WAS TAKEN FROM BISMARCK. THEY BOTH REFUSED MEDICAL ASSISTANCE. OFFICERS WENT TO THE BUSINESS WHERE THE INCIDENT OCCURRED. UPON ARRIVAL, AN OFFICER OBSERVED TWO MALES WALKING INTO SUITE P6. OFFICERS TOLD THE SUBJECTS TO COME DOWN TO TALK BUT THEY CONTINUED TO WALK IN AND CLOSED THE DOOR. OFFICERS SURROUNDED THE PROPERTY. OFFICERS KNOCKED MULTIPLE TIMES AT SUITE P6 BUT NO ONE CAME OUT. 1L37 AND MAJOR CRIMES DETECTIVES ARRIVED ON SCENE.

MS. BENSON (VICTIM THREE) WAS OUTSIDE OF HER SUITE P5. SHE STATED, SHE BELIEVED SOMEONE WAS INSIDE HER BUSINESS AND GAVE CONSENT FOR OFFICERS TO CHECK THE BUSINESS. OFFICERS FOUND MR. HAMPTON IN SUITE P5 AND HE WAS TAKEN INTO CUSTODY (HANDCUFFED, DOUBLE LOCKED AND CHECKED FOR TIGHTNESS. MR. HAMPTON HAD CRAWLED THROUGH THE ATTIC FROM P6 TO P5. THERE WAS DAMAGED CEILING TILES ON THE FLOOR OF P5. MR. BATTLES (CONTACT ONE) WALKED OUT OF SUITE P6 AND WAS DETAINED. HE WAS HANDCUFFED, DOUBLE LOCKED AND CHECKED FOR TIGHTNESS. MR. HAMPTON AND MR. BATTLES WERE TRANSPORTED TO THE MAJOR CRIMES DETECTIVE'S OFFICE. AFTER SECURING SUITES P6 AND P5 OFFICERS STOOD BY AND WAITED FOR A SEARCH WARRANT.

ONCE THE WARRANT WAS SIGNED, OFFICERS MADE ENTRY AND LOCATED BISMARCK'S STOLEN PROPERTY IN SUITE P6. BISMARCK AND JOSEPH WERE TRANSPORTED TO THE MAJOR CRIME'S DETECTIVE'S OFFICE WHERE THEY PROVIDED A STATEMENT AND GIVEN THE REPORT NUMBER. MR. BATTLES WAS RELEASED WITHOUT CHARGES AND MR. HAMPTON WAS TRANSPORTED TO PCRJ. HE WAS BOOKED IN FOR AGGRAVATED ROBBERY, THEFT OF PROPERTY AND COMMERCIAL BURGLARY. BWC WAS IN USE.
