## **NARRATIVE**

ON 09/16/2025, AT APPROXIMATELY 1140, OFFICERS RESPONDED TO 925 FAIR PARK BLVD (CIRCLE K) FOR A DELAYED THEFT REPORT. OFFICERS MADE CONTACT WITH JASON RINGO (VICTIM) IN THE PARKING LOT AT THIS LOCATION. RINGO ADVISED HE OVERDOSED ON NARCOTICS LAST NIGHT, AND WAS TAKEN TO THE HOSPITAL. RINGO ADVISED WHEN HE GOT OUT OF THE HOSPITAL AROUND 0530 THIS MORNING "BIG O" WAS WAITING TO GIVE HIM A RIDE. RINGO ADVISED BIG O DRIVES A RED 2014 FORD F150 WITH A LICENSE PLATE FROM THE CAR DEALERSHIP RINGO WORKS AT (5900 S UNIVERSITY AVE). RINGO ADVISED BIG O WAS SELLING THEM A VEHICLE EARLIER, BUT BIG O DID NOT WANT TO BE PAID WITH A CHECK. RINGO ADVISED BIG O PULLED OUT A PISTOL AND PLACED IT ON HIS LAP WHILE HE WAS DRIVING, BUT NEVER THREATENED HIM WITH IT. RINGO ADVISED THEY GOT TO THE CIRCLE K AROUND 0700 HOURS. RINGO ADVISED HE PAID FOR GAS INSIDE. RINGO ADVISED WHEN HE DID THAT BIG O GRABBED RINGO'S WALLET, AND PAID WITH THE WALLET, RINGO ADVISED HE TOOK THE WALLET BACK FROM BIG O, BUT BIG O GRABBED IT AGAIN. RINGO ADVISED BIG O GAVE HIM BACK HIS WALLET. RINGO ADVISED HE HAD OVER \$2,800 IN HIS WALLET, AND WHEN BIG O GAVE IT BACK THERE WAS ONLY \$100 LEFT IN THE WALLET. RINGO ADVISED HE ASKED BIG O TO GIVE HIM BACK HIS MONEY, BUT BIG O WOULD NOT DO IT. RINGO ADVISED HE TOLD BIG O, OK I'LL BUY THE CAR FROM YOU, AND I'LL GIVE YOU THE REST OF THE MONEY LATER, BUT BIG O DID NOT AGREE. RINGO ADVISED ANOTHER B/M WAS THERE DISTRACTING HIM WHILE BIG O TOOK HIS MONEY. IT WAS A LITTLE DIFFICULT TO FOLLOW RINGO'S STATEMENT. POSSIBLY DUE TO THE EFFECTS FROM OVERDOSING ON NARCOTICS HOURS EARLIER. RINGO ADVISED BIG O LEFT WITH HIS MONEY. RINGO ADVISED HE SHOULD BE ABLE TO GET BIG O'S INFORMATION FROM THE CAR DEALERSHIP. OFFICERS MADE CONTACT WITH CIRCLE K MANAGER JONATHON HOLLIDAY (CONTACT). HOLLIDAY WAS ABLE TO SHOW OFFICERS THE VIDEO OF RINGO AND BIG O, AND BIG O TAKING RINGO'S WALLET AT THE COUNTER. OFFICERS OBSERVED THE RED F150 WITH LPN (EX 69033). OFFICERS DID OBSERVE AN UNKNOWN BLACK MALE SHOW UP LATER WHILE RINGO AND BIG O WERE AT THE GAS PUMP. MVR WAS IN USE.
