NARRATIVE

OFFICERS WENT TO 1722 DR. MARTIN LUTHER KING DRIVE FOR A SUSPICIOUS PERSON CALL. THE CALLER ADVISED THAT SOMEONE IS OUTSIDE HER HOME BEATING ON HER DOOR AND WINDOWS. THE SUBJECT OUTSIDE IS SAYING THEY WERE ASSAULTED AND WAS BLEEDING FROM THE HEAD. UPON ARRIVAL, OFFICERS MADE CONTACT WITH HAYWARD JEFFERSON, WHO HAD A LACERATION ABOVE HIS RIGHT EYEBROW THAT WAS BLEEDING. THE CALLER THEN STEPPED OUTSIDE AND REALISED THAT IT WAS HAYWARD, HER BROTHER. HAYWARD DOES NOT LIVE WITH HER BUT RUNS TO HER HOME WHEN HE IS IN TROUBLE. HAYWARD STATED HE WAS AT 1910 S. PULASKI STREET WITH HIS EX-GIRLFRIEND, LATOYA DAVIS. LATOYA WANTED HAYWARD TO GIVE HER HIS MONEY, AND HE REFUSED TO DO SO. WHILE ON THE FRONT PORCH, LATOYA TRIED TO HIT HAYWARD WITH A SILVER PADLOCK BUT MISSED. HAYWARD THEN PUSHED LATOYA DOWN. THE CURRENT TENANT OF THE RESIDENCE, WHO GOES BY THE NAME OF "B," GRABBED HAYWARD AND PINNED HIM AGAINST THE METAL PORCH BEAM. LATOYA THEN STRUCK HAYWARD IN THE FACE WITH THE PADLOCK. ALSO, WHILE BEING PINNED TO THE BEAM, EITHER "B" OR LATOYA WENT IN HIS POCKET AND TOOK HIS 20-DOLLAR BILL. HAYWARD THEN RAN TO 1722 DR. MARTIN LUTHER KING DRIVE TO GET HELP. MEMS RESPONDED AND TRANSPORTED HAYWARD TO UAMS. OFFICERS THEN WENT TO 1910 S. PULASKI STREET IN AN ATTEMPT TO LOCATE LATOYA AND/OR "B". OFFICERS OBSERVED BLOOD ON THE FRONT PORCH LEADING FROM THE BEAM BY THE STEPS. OFFICERS ALSO OBSERVED A SILVER PADLOCK WITH BLOOD ON IT PLACED ON TOP OF A WASHER MACHINE NEXT TO THE PORCH. OFFICERS KNOCKED ON THE DOOR, AND A BLACK FEMALE CAME TO THE DOOR. THE FEMALE DID NOT RESEMBLE LATOYA, AND SHE REFUSED TO COME OUTSIDE OR OPEN THE DOOR. SHE STATED SHE WAS GOING TO GET THE OWNER OF THE HOUSE. A MALE FROM INSIDE STATED HE WAS THE HOME OWNER AND THAT NOTHING HAPPENED AT HIS RESIDENCE. OFFICERS ASKED THE MALE TO COME OUTSIDE AND SPEAK TO THE OFFICERS, AND HE ALSO REFUSED. OFFICERS INFORMED A DOWNTOWN SUPERVISOR OF THE INCIDENT. OFFICERS TOOK PHOTOS OF THE BLOOD ON THE PORCH, TOOK THE PADLOCK, AND STORED IT IN THE 12TH STREET PROPERTY ROOM. NO FURTHER POLICE ACTIONS WERE TAKEN, AND BWC/MVR WAS IN USE.
