OFFICERS WERE DISPATCHED TO BAPTIST HOSPITAL FOR A SHOOTING REPORT. OFFICERS MADE CONTACT WITH THE VICTIM, ANDARIUS HARSTON. HARSTON STATED HE WAS WALKING NORTHBOUND ON TYLER ST. POSSIBLY BETWEEN 25TH AND 24TH ST., WHEN A TAN/BROWN CHEVY TAHOE DROVE BY WITH HIM BEING SHOT IN THE LEFT THIGH. HARSTON ADVISED HE WAS WALKING TO HIS GIRLFRIENDS HOUSE LOCATED AT 2307 S. TYLER ST. HARSTON WAS UNCOOPERATIVE ON STAYING AT THE HOSPITAL TO SPEAK WITH DETECTIVES AND NO LONGER WANTED TO SPEAK WITH OFFICERS AFTER INITIALLY PROVIDING INFORMATION.

OFFICERS WERE SENT TO THE AREA IN ATTEMPT TO LOCATE A CRIME SCENE WITH NEGATIVE RESULTS. MAJOR CRIMES AND THE ON SHIFT SERGEANT WERE NOTIFIED. OFFICERS MADE CONTACT WITH THE RESIDENT AT 2307 S. TYLER ST. WITH HER ADVISING SHE HAD NO IDEA WHO HARSTON WAS. SHE DID NOT WANT TO PROVIDE HER INFORMATION. OFFICERS MADE CONTACT WITH MR. PERKINS IN THE FRONT OFFICE AT THE CROSSINGS OF NANDINA. MR. PERKINS ADVISED AT APPROXIMATELY 1400 HOURS, HE WAS WALKING BACK TOWARD HIS APARTMENT FROM THE CORNER STORE WITH A BAG OF CHIPS AND SNACKS WHEN 5 MALE SUBJECTS APPROACHED HIM FROM MULTIPLE AREAS AND SURROUNDED HIM.
