#### **NARRATIVE**

ON TODAYS DATE COMMUNICATIONS RECEIVED A CALL IN REGARD TO A SHOOTING.

UPON ARRIVAL, OFFICERS NOTICED A BLACK MALE WITH A GUN SHOT WOUND TO HIS LEFT CALF. OFFICERS APPLIED A TOURNIQUET TO THE VICTIM AFTER ADVISING DISPATCH TO SEND IN MEMS. THE VICTIM, DARIUS JERRETT, STATED HE WAS OUTSIDE MOVING HIS BELONGINGS WHEN A BLACK OR GREY VEHICLE DROVE BY AND SHOT AT HIM. JARRETT STATED ONCE SHOT, HE RAN AND JUMPED SEVERAL FENCES IN ORDER TO GET AWAY FROM THE SHOOTER. JARRETT WAS TRANSPORTED TO UAMS WERE HE WAS TREATED FOR HIS INJURY.

UPON SPEAKING WITH CHARLES BOLDEN, HE STATED HE WAS AT THE RESIDENCE CHANGING THE LOCKS WHEN SOMEONE BEGAN SHOOTING. BOLDEN STATED HE DID NOT SEE THE SHOOTERS OR THE SUSPECT VEHICLE BECAUSE HE DUCTED BEHIND A VEHICLE TO AVOID BEING SHOT.

UPON SPEAKING WITH ROBERT PIERCE, HE STATED HIS HOME WAS SHOT THREE TIMES DURING THE SHOOTING. PIERCE ALSO STATED HE DID NOT SEE THE SHOOTER OR SUSPECT VEHICLE.

OFFICERS FOLLOWED DARIUS JERRETT TO UAMS.

#### **NARRATIVE**

OFFICERS MADE CONTACT WITH MR. PERKINS IN THE FRONT OFFICE AT THE CROSSINGS OF NANDINA. MR. PERKINS ADVISED AT APPROXIMATELY 1400 HOURS. HE WAS WALKING BACK TOWARD HIS APARTMENT FROM THE CORNER STORE WITH A BAG OF CHIPS AND SNACKS WHEN 5 MALE SUBJECTS APPROACHED HIM FROM MULTIPLE AREAS AND SURROUNDED HIM. HE ADVISED THE MALE SUBJECTS ALL LOOKED TO BE IN THEIR EARLY 20S AND WERE ALL WEARING DARK COLORED HOODIES AND PANTS EXCEPT ONE WHO WAS WEARING A RED HOODIE. HE ADVISED TWO OF THEM HAD DREADS AND THE OTHER THREE HAD LOW HAIRCUTS AND THEY WERE ALL WEARING SKI MASKS ON THEIR HEADS BUT WERE NOT COVERING THEIR FACES WITH THEM. MR. PERKINS ADVISED FOUR THE SUBJECTS HAD HANDGUNS AND POINTED THEM AT HIM AND TOLD HIM TO HAND OVER HIS STUFF AND THEY TOOK HIS BAG OF SNACKS AND HIS CELL PHONE BEFORE LEAVING THE AREA ON FOOT THROUGH AN OPENING IN THE FENCE AT THE REAR OF THE PROPERTY NEAR BUILDING 19. MR. PERKINS ADVISED HE HAD NO WAY TO TRACK HIS CELL PHONE AT THIS TIME. OFFICERS MADE CONTACT WITH THE PROPERTY MANAGER WHO ADVISED THEY HAD NO CAMERAS ON THE PROPERTY THAT WOULD HAVE CAPTURED THE INCIDENT AND THAT SHE HAD CIRCULATED THE AREA AFTER HE TOLD HER ABOUT IT AND DIDN'T SEE ANYTHING. OFFICERS CIRCULATED THE AREA FOR THE SUSPECTS WITH NEGATIVE RESULTS AND PUT OUT A BROADCAST FOR OTHER UNITS. MR.
