## **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A DISTURBANCE. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. SAMER MASRI WHO ADVISED ON 10/18/2025 HIS ROOMATE, MR. AMIR ALI STOLE \$2600 FROM UNDERNEATH HIS BED. MASRI ADVISED WHILE STEALING THE MONEY, ALI SHOVED MASRI AWAY, PREVENTING HIM FROM STOPPING ALI. MASRI ALSO ADVISED AFTER BEING SHOVED, ALI DISPLAYED A FIREARM THAT WAS STILL IN HIS WAISTBAND AND ASKED MASRI "WHAT ARE YOU GOING TO DO ABOUT IT?" BEFORE LEAVING WITH THE CASH. OFFICERS MADE CONTACT WITH YOUSEF ALSABAHA WHO WAS ALSO A ROOMATE WHO ADVISED HE WITNESSED THE ENTIRE INCIDENT.

ALSABAHA ALSO ADVISED ALI STATED "YEAH I STOLE IT" AFTER ALSABAHA ASKED HIM IF HE WAS REALLY STEALING THE MONEY. OFFICERS COMPLETED A LETHALITY FORM WITH MASRI AND PROVIDED HIM WITH A LAURAS CARD AS THE SITUATION WAS DOMESTIC IN LIEU OF MASRI AND ALI BEING ROOMATES. OFFICERS WERE ADVISED ALI WORKED AT 1914 PARKWAY DRIVE IN NORTH LITTLE ROCK. OFFICERS CONDUCTED AN AGGRAVATED ROBBERY BROADCAST.

OFFICERS ADVISED NORTH LITTLE ROCK POLICE DEPARTMENT ALI WAS POSSIBLY AT 1914 PARKWAY DRIVE IN NORTH LITTLE ROCK. NORTH LITTLE ROCK POLICE DEPARTMENT ADVISED LITTLE ROCK POLICE OFFICERS THEY HAD ALI LOCATED AND DETAINED. OFFICERS CONTACTED DETECTIVES WHO ADVISED OFFICERS TO HAVE ALI LET GO AS AN ARREST COULD NOT BE MADE AT THE TIME. OFFICERS ADVISED NORTH LITTLE ROCK POLICE DEPARTMENT THEY COULD RELEASE ALI.

NORTH LITTLE ROCK POLICE DEPARTMENT COMPLIED. OFFICERS PROVIDED MASRI WITH AN INCIDENT CARD AND ADVISED HIM TO CONTACT POLICE IF ANY FURTHER CONTACT WAS NECESSARY. OFFICERS LEFT THE SCENE WITHOUT INCIDENT. A SUPERVISOR WAS AWARE OF THE SITUATION. BODY WORN CAMERA AND MOTOR VEHICLE RECORDING IN USE.
