NARRATIVE

OFFICERS RESPONDED TO A CRIMINAL MISCHIEF AT THE LISTED LOCATION. THE CALLER, MS. HERNANDEZ, ADVISED HER BOYFRIEND, MR. IZAGUIRRE, DAMAGED THE WINDOW TO VEH 1. VEH 1 WAS LATER FOUND TO BELONG TO MR. IZAGUIRRE.

UPON ARRIVING ON SCENE, OFFICERS OBSERVED A WHOLE IN THE FRONT PASSENGER DOOR WINDOW TO VEH 1. OFFICERS MADE CONTACT WITH MS. HERNANDEZ WHO ADVISED SHE HAD JUST RETURNED FROM A BABY SHOWER WHEN HER BOYFRIEND ASSAULTED HER IN THEIR BEDROOM. DURING THE ASSAULT, MS. HERNANDEZ ALLEGED MR. IZAGUIRRE THREW HER ON THE BED AND ATTEMPTED TO GRAB HER BY THE NECK. WHEN MS. HERNANDEZ REMOVED HIS HANDS FROM HIS NECK, SHE ALLEGED HE THEN BEGAN TO STRIKE HER FACE. DURING THE ATTACK, MS. HERNANDEZ STATED SHE PUT HER HANDS UP TO DEFEND HERSELF FROM THE STRIKES, WHICH WOULD CAUSE A SMALL LACERATION TO HER FINGER.

AFTER THE ASSAULT, MS. HERNANDEZ STATED MR. IZAGUIRRE EXITED THE RESIDENCE, DESTROYED THE FRONT PASSENGER WINDOW OF VEH 1, AND RETRIEVED A PURPLE WALLET THAT BELONGED TO HER FROM THE GLOVE BOX COMPARTMENT. THE WALLET CONTAINED APPROXIMATELY 500-600 IN DIFFERENT DENOMINATIONS, CREDIT CARDS THAT BELONGED TO MS. HERNANDEZ, A WIC CARD THAT ALSO BELONGED TO MS. HERNANDEZ, AND HEALTHCARE CARDS THAT BELONGED TO HER CHILDREN. MS. HERNANDEZ ALLEGED WHEN SHE ATTEMPTED TO RETRIEVE HER WALLET BACK, MR. IZAGUIRRE RAISED A SCREWDRIVER OVER HIS HEAD IN A STABBING MOTION, WHICH PROMPTED HER TO STAY AWAY FROM HIM. MR. IZAGUIRRE WOULD THEN LEAVE THE AREA IN A SILVER TOYOTA TACOMA.

OFFICERS MADE CONTACT WITH JUV 1 WHO ADVISED HE WAS AWAKEN TO A LOUD DISTURBANCE BUT DID NOT WITNESS THE INCIDENT.

A LETHALITY ASSESSMENT WAS CONDUCTED, AND MS. HERNANDEZ WAS ISSUED A LAURA'S CARD. OFFICERS MADE A BROADCAST OVER MAIN CHANNEL FOR THE SUSPECT AND SUSPECT VEHICLE. MS. HERNANDEZ DECLINED MEDICAL AND DID NOT WISH FOR OFFICERS TO TAKE PHOTOS OF HER INJURIES. NO FURTHER ACTION WAS TAKEN. MVR/BWC IN USE.

NARRATIVE

OFFICERS WERE DISPATCHED TO 505 SHAMROCK DRIVE IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE CALLER, ZACHARY KELLERMAN. KELLERMAN ADVISED THAT HE HAD JUST BEEN ROBBED BY A SUBJECT NAMED "DANTAVION" (LATER IDENTIFIED AS DANTAVION HILL). KELLER DETAILED THAT HE HAD LET HILL INTO THE RESIDENCE AT 505 SHAMROCK DRIVE BECAUSE HE KNEW HIM AS AN ACQUAINTANCE. KELLERMAN STATED THAT HILL THEN ALLOWED TWO OTHER UNKNOWN MALE SUBJECTS INTO THE HOUSE. KELLERMAN ADVISED THAT HE PROTESTED HILL LETTING IN TWO OTHER SUBJECTS. KELLERMAN ADVISED THAT HILL WAS HUDDLED IN THE CORNER OF THE LIVING ROOM WITH ONE OF THE TWO UNKNOWN SUBJECTS. KELLERMAN DETAILED THAT HE THEN ASKED HILL WHAT HE WAS UP TO. KELLERMAN STATED THAT HILL THEN TURNED AROUND A PULLED OUT A BLACK PISTOL WITH A LARGE DRUM MAGAZINE, POINTING IT AT KELLERMAN. KELLERMAN DETAILED THAT HILL THEN BEGAN DEMANDING KELLERMAN TO GIVE HILL ALL THE MONEY HE POSSESSED AS WELL AS ACCESS TO HIS BANK APP ON HIS CELL PHONE. KELLERMAN ADVISED THAT HE TOLD HILL HE WOULD NOT GIVE HIM ACCESS TO HIS PHONE. KELLERMAN DETAILED HE THEN GAVE HILL \$125 IN CASH BUT HILL STILL FORCEFULLY TOOK KELLERMAN'S PHONE FROM HIM. KELLERMAN STATED THAT WHILE FORCEFULLY TAKING HIS PHONE. HILL PISTOL-WHIPPED KELLERMAN ON THE HEAD AND PUNCHED HIM REPEATEDLY. KELLERMAN ADVISED THAT THE TWO UNKNOWN SUSPECTS ALSO CONTINUE TO EMPTY HIS POCKETS WHILE KELLERMAN WAS UNDER DURESS. OFFICERS OBSERVED A KNOT FORMING ON THE RIGHT SIDE OF KELLERMAN'S HEAD, PRESUMABLY FROM THE PISTOL-WHIP. KELLERMAN DETAILED THAT HILL THEN TOOK KELLERMAN'S DRAWSTRING BACKPACK WITH ASSORTED MERCHANDISE INSIDE. KELLERMAN ADVISED THAT HILL AND THE TWO UNKNOWN SUSPECTS THEN LEFT IN A WHITE SEDAN. KELLERMAN STATED TO OFFICERS THAT HILL POSSIBLY LIVES AT 104 HIAWATHA DUE TO KELLERMAN PREVIOUSLY DROPPING HILL OFF THERE.

OFFICERS THEN WENT TO 104 HIAWATHA DRIVE TO INVESTIGATE FURTHER. OFFICERS ARRIVED AT HIAWATHA AND OBSERVED THE LISTED VEHICLE PARKED IN THE CAR PORT OF THE ADDRESS. OFFICERS MADE CONTACT WITH THE VEHICLE AND IDENTIFIED THE DRIVER AS SAVION JACKSON, THE BACK PASSENGER SEAT AS J1, AND THE FRONT PASSENGER AS DANTAVION HILL. OFFICERS ASKED HILL TO STEP OUT OF THE VEHICLE, WHICH HE DID. OFFICERS PLACED HILL IN HANDCUFFS, SEARCHED HIM, AND PLACED HIM IN THE BACK OF A PATROL VEHICLE. OFFICERS ASKED JACKSON AND J1 TO EXIT THE VEHICLE, WHICH THEY DID WITHOUT INCIDENT. OFFICERS THEN CONTACTED MAJOR CRIMES DETECTIVES AND ALERTED THEM OF THE SITUATION. OFFICERS THEN OBSERVED A DRUM MAGAZINE TO A PISTOL STICKING OUT FROM UNDERNEATH THE FRONT PASSENGER SEAT OF THE LISTED VEHICLE. OFFICERS ASKED JACKSON FOR PERMISSION TO SEARCH THE FRONT PASSENGER SEAT OF THE VEHICLE, WHICH HE ALLOWED. OFFICERS LOCATED A BLACK PISTOL WITH A DRUM MAGAZINE, MATCHING THE DESCRIPTION GIVEN BY KELLERMAN.

OFFICERS THEN MADE CONTACT WITH THE OWNER OF THE LISTED ADDRESS, ALEXIS WILSON. OFFICERS ASKED WILSON FOR PERMISSION TO SEARCH THE HOUSE FOR THE STOLEN ITEMS, WHICH WILSON AGREED TO. OFFICERS CONDUCTED A SEARCH OF THE HOUSE BUT DID NOT LOCATE THE STOLEN ITEMS. OFFICERS THEN TRANSPORTED HILL TO THE 12TH STREET DETECTIVE'S OFFICE FOR INTERVIEWS. OFFICERS ALSO TRANSPORTED KELLERMAN TO THE 12TH STREET DETECTIVE'S OFFICE. KELLERMAN ADVISED OFFICERS THAT HE LATER LOCATED HIS PHONE USING THE "FIND MY" APP. KELLERMAN ADVISED THAT HE LOCATED THE PHONE IN A BUSH AT THE INTERSECTION OF SHAMROCK AND CORNELL DRIVE.

AFTER INTERVIEWS WERE COMPLETED, OFFICERS TRANSPORTED HILL TO PCRJ TO BE BOOKED IN ON THE CHARGES OF AGGRAVATED ROBBERY AND THEFT OF PROPERTY. OFFICERS STORED ALL EVIDENCE AT THE NORTHWEST SUBSTATION PROPERTY ROOM. MAJOR CRIMES DETECTIVES CREATED A REFERRAL ON KARPEL FOR HILL. MVR AND BWC IN USE.
