NARRATIVE

OFFICERS RESPONDED TO THE 12TH STREET SUBSTATION IN REFRENCE TO A DOMESTIC BATTERY REPORT.

OFFICERS MADE CONTACT WITH VICTIM 1, MS. NELSON, WHO REPORTED A DOMESTIC DISTURBANCE INVOLVING HER BOYFRIEND OF TWO YEARS, MR. DOTS. MS. NELSON STATED MR. DOTS BECAME IRATE AND CALLED HER "CHILDISH" AFTER FAILING TO PICK UP HER DAUGHTER FROM SCHOOL AS PREVIOUSLY AGREED. SHE REPORTED MR. DOTS ANNOUNCED HE WAS LEAVING AND THEN ATTEMPTED TO TAKE MONEY FROM HER PURSE.

IN HER ATTEMPT TO RETRIEVE THE BAG, MS. NELSON STATED SHE WAS DRAGGED FROM OUTSIDE THE RESIDENCE INTO THE HOME. WHILE SHE WAS HANGING OVER THE COUCH, SHE REPORTED MR. DOTS BIT HER ON THE LEFT LEG. OFFICERS OBSERVED WHAT APPEARED TO BE A RECENT BITE MARK ON HER LEG.

MS. NELSON ADVISED MR. DOTS LEFT THE RESIDENCE IN A BLACK TRUCK WITH A TRAILER ATTACHED AND TOOK \$560 IN CASH FROM HER PURSE. OFFICERS PROVIDED MS. NARRATIVE

NARRATIVE

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A BATTERY. OFFICERS MADE CONTACT WITH DONNA BLUNT.

BLUNT ADVISED SHE WAS LOADING UP HER TRUCK AT A HOMELESS CAMP NEAR 4821 S UNIVERSITY WHEN SHE WAS APPROACHED BY A BLACK MALE, POSSIBLY FREDERICK BANKS (APPROXIMATELY 30 YEARS OF AGE). NARRATIVE

ON 11/02/2025 OFFICERS WERE DISPATCHED TO A THEFT JUST OCCURRED AT THE LULU LEMON STORE AT 17819 CHENAL PARKWAY. WHILE EN ROUTE TO THE CALL THE NOTES UPDATED STATING AN EMPLOYEE WAS ASSAULTED BY ONE OF THE SUSPECTS. OFFICERS ARRIVED MAKING CONTACT WITH THE MANAGER IDENTIFIED AS BRIAN DOMINGUS (A/M 09/30/1993). MR. DOMINGUS ADVISED THERE WERE 6 B/F WHO ENTERED THE STORE AT APPROXIMATELY 1737HOURS. MR. DOMINGUS ADVISED THE STORE STAFF RECOGNIZED THE SUSPECTS FROM PREVIOUS THEFTS FROM THE STORE. MR. DOMINGUS ADVISED FOUR OF THE SIX SUSPECTS WERE ALSO OBSERVED ON A FLIER FROM THE ATTORNEY GENERALS' OFFICE. MR. DOMINGUS ADVISED THE FEMALE SUSPECTS BEGAN CLEARING THE SHELVES OF ITEMS AND ONE SUSPECT BEGAN LOADING CLOTHES INTO A LARGE TOTE BAG. MR. DOMINGUS ADVISED ONCE HE OBSERVED WHAT WAS HAPPENING, HE WENT TO THE FRONT DOOR OF THE STORE IN AN ATTEMPT TO LOCK IT. MR. DOMINGUS ADVISED WHEN THE SUSPECTS HEARD MR. DOMINGUS BEGIN TO LOCK THE DOORS THEY STAMPEDED TOWARD HIM IN AN ATTEMPT TO EXIT. MR. DOMINGUS ADVISED THE SUSPECTS PUSHED HIM OUT OF THE WAY WITH LARGE AMMOUNTS OF UNPAID MERCHANDISE IN THEIR ARMS.

OFFICERS THEN SPOKE TO MS. MADELYNE SPENCER (06/09/2000). MS. SPENCER ADVISED SHE WAS WORKING WHEN SHE OBSERVED MULTIPLE INDIVIDUALS ENTER THE STORE WHO SHE RECOGNIZED FROM PREVIOUS THEFTS. MS. SPENCER ADVISED SHE CALLED OUT ONE OF THE SUSPECTS BY NAME (JEWEALLI YOUNG). MS. SPENCER ADVISED SHE OBSERVED THE SUSPECTS LOADING THEIR ARMS WITH MERCHANDISE. MS. SPENCER ADVISED HER MANAGER WENT TO LOCK THE FRONT DOOR AND SHE STOOD AT THE FRONT OF THE STORE WITH HIM. MS. SPENCER ADVISED WHEN ONE OF THE SUSPECTS WAS LEAVING (UNIDENTIFIED AT THIS TIME) SHE PUNCHED MS. SPENCER IN THE LEFT SIDE CHEST REGION. MS. OFFICERS RECOVERED MULTIPLE FINGERPRINT AND PALM PRINTS FROM THE FRONT DOOR WINDOW GLASS. OFFICERS STORED THE FINGERPRINTS AND SUSPECT SHOE AT THE NORTHWEST SUBSTATION. MVR AND BWC IN USE. NO FURTHER INFORMATION AT THIS TIME.
