NARRATIVE

MVR/BWC IN USE.

ON 11/04/2025, AT APPROXIMATELY 2249 HOURS, OFFICERS WERE DISPATCHED TO 212 CENTER STREET IN REFERENCE TO A SHOTS FIRED CALL. WHILE EN ROUTE TO THE INCIDENT, OFFICERS WERE FLAGGED DOWN AT THE INTERSECTION OF 2ND AND CUMBERLAND BY THE VICTIMS IN A BLACK 2018 CHEVY MALIBU, BEARING ARKANSAS LICENSE PLATE AUR55I.

OFFICERS MADE CONTACT WITH THE VICTIMS, KURISTAN ANDERSON, TRESJOIR JOHNSON, AND OMARION HUNTER. OFFICERS ASKED EACH VICTIM IF MEDICAL ATTENTION WAS NEEDED AND IT WAS DENIED. OFFICERS THEN REQUESTED THE VICTIMS TO GET OUT OF THE VEHICLE, DUE TO IT BEING A CRIME SCENE.

WHILE INVESTIGATING AND OBTAINING STATEMENTS, MS. JOHNSON INFORMED OFFICERS SHE HAD BEEN SHOT IN THE BACK OF THE HEAD BUT THAT SHE DID NOT HAVE ANY VISIBLE INJURIES. OFFICERS THEN REQUESTED MEMS TO COME CHECK HER OUT. OFFICERS DID OBSERVE A HOLE AND BURN MARK IN MS. JOHNSON'S WIG.

ALL OF THE VICTIMS ADVISED OFFICERS THAT THEY HAD MET 2 UNKNOWN BLACK MALES AT THE JUNCTION BRIDGE AS THEY WERE PASSING BY. THE 2 MALES STATED THAT THEY HAD SEEN THE VICTIMS ON TINDER AND THOUGHT THEY LOOKED NICE. THE 2 MALES THEN WALKED OFF AS 3 OTHER UNKNOWN FEMALES WERE PASSING BY.

AS THE VICTIMS WERE LEAVING, THEY STATED AN OLDER MODEL BLACK SEDAN THAT WAS BEING DRIVEN BY ONE OF THE UNKNOWN MALES THAT THEY HAD MET IN THE PARK WAS STOPPED AT THE INTERSECTION OF 2ND AND MAIN. THE VICTIM DRIVER, OMARION HUNTER, THEN STATED HE HONKED THE HORN AT THEM TO GET THEM TO DRIVE AND THEN THE DRIVER THREW A BOTTLE OF ALCOHOL AT THEIR VEHICLE. MR. HUNTER THEN GOT IN FRONT OF THE VEHICLE AND THREW A CAN OUT OF ANGER BACK AT THE OTHER VEHICLE. AS MR. HUNTER WAS GETTING BACK INTO HIS VEHICLE THE MALE IN THE OTHER VEHICLE BEGAN SHOOTING AT THE VICTIMS. THE VICTIMS STATED THEY HEARD APPROXIMATELY 3 SHOTS BEING FIRED.

OFFICERS DID OBSERVE AN ENTRY BULLET HOLE LOCATED ON THE TRUNK OF THE VEHICLE. THERE WAS ALSO AN EXIT HOLE LOCATED IN THE FRONT PASSENGER SIDE OF THE WINDSHIELD. OFFICERS LOCATED A BULLET FRAGMENT IN THE WINDSHIELD WIPER BAY OF THE VEHICLE.
