## **NARRATIVE**

ON 11/05/2025 OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A ROBBERY.

UPON ARRIVAL OFFICERS MADE CONTACT WITH MR. CLARK. MR. CLARK ADVISED AN UNKNOWN BLACK MALE WEARING ALL BLACK WITH A BLACK MASK ON WALKED UP THE STAIRS AT THE LOCATION AND POINTED A GUN AT HIM AND TOLD HIM "GIVE ME WHATEVER YOU GOT". MR. CLARK ADVISED THE SUSPECT POINTED A SMALL BLACK GLOCK HANDGUN AT HIM DURING THE INCIDENT. MR. CLARK ADVISED THE SUSPECT TOOK HIS PHONE AND THE KEYS TO THE LISTED VEHICLE IN THE INCIDENT. MR. CLARK ADVISED ONCE HE GAVE THE SUSPECT HIS KEYS AND PHONE HE RAN SOUTHBOUND THROUGH THE COMPLEX.

OFFICERS NOTIFIED A SUPERVISOR AND MAJOR CRIMES DETECTIVES OF THE INCIDENT. OFFICERS THEN BROAD CASTED WHAT INFORMATION MR. CLARK PROVIDED TO THE ALL OFFICERS ON DUTY. OFFICERS ALSO CIRCULATED THE AREA IN SEARCH OF A POSSIBLE SUSPECT WITH NEGATIVE RESULTS.
