NARRATIVE

OFFICERS RESPONDED TO A THEFT CALL AT THE DOLLAR GENERAL AND MADE CONTACT WITH ALBERT EVANS. MR. EVANS STATED HE IS THE DISTRICT MANAGER AND REPORTED A ROBBERY. MR. EVANS STATED A BLACK FEMALE WEARING A PURPLE BONNET, JEANS AND A BLACK JACKET ENTERED THE STORE AND LOADED UNKNOWN ITEMS INTO HER LARGE PURSE. MR. EVANS STATED HE AND HIS STORE MANAGER CONFRONTED THE SUSPECT AS SHE EXITED THE STORE AND WALKED TO HER LISTED HYUNDAI SONATA. MR. EVANS STATED HE ASKED THE WOMAN TO SHOW HIM WHAT WAS IN HER BAG AND SHE REPLIED " I HAVE A GUN". MR. EVANS STATED THE SUSPECT ENTERED HER LISTED VEHICLE AND DROVE AWAY FROM THE STORE.

OFFICERS MADE CONTACT WITH GERI TRETTFORD, THE STORE MANAGER. MS. TRETTFORD STATED THE SUSPECT WALKED OUT OF THE STORE AND SHE CONFRONTED HER ABOUT ITEMS IN HER BAG. MS. TRETTFORD STATED THE SUSPECT ENTERED HER VEHICLE AND STATED "I HAVE A GUN AND ILL PULL IT OUT AND USE IT". MS. TRETTFORD STATED THE SUSPECT DROVE AWAY FROM THE STORE BUT SHE WAS ABLE TO READ THE LICENSE PLATE.

OFFICERS MADE CONTACT WITH TIESHA PARRIS, WHO IS THE CASHIER AT THE STORE. MS. PARRIS STATED SHE FOLLOWED HER MANAGERS OUTSIDE BUT DID NOT HEAR THE SUSPECT SAY THE THREATS DUE TO THEM BEING SAID BEFORE SHE CAME OUTSIDE.

OFFICERS RAN THE TAGS OF THE SUSPECT VEHICLE AND RESPONDED TO THE ADDRESS IT RETURNED TO AT 9100 TEDBURN. OFFICERS LOCATED THE VEHICLE AND THE SUSPECT EXITING IT AT THE ADDRESS. OFFICERS MADE CONTACT WITH ALEXANDRA WILLIAMS, AND TOOK HER INTO CUSTODY.
