OFFICERS CLEARED THE REMAINDER OF THE STRUCTURE AND LOCATED A SMALL BROKEN WINDOW PANE IN THE BACK OFFICE, MR. PARK STATED HE BELIEVED CASH (5 TWENTY DOLLAR BILLS) WAS MISSING FROM NEAR THE REGISTER AREA. OFFICERS OBSERVED MULTIPLE CAMERAS INSIDE THE BUSINESS AND REQUESTED TO VIEW THE FOOTAGE. MR. PARK SHOWED OFFICERS FOOTAGE OF THE INCIDENT. WHILE LOCKED IN THE STORE, OFFICERS OBSERVED MR. COURTNEY GO BEHIND THE COUNTER TO THE REGISTER AREA AND LEAVE FROM BEHIND THE COUNTER WITH WHAT APPEARED TO BE CASH IN HIS HAND. HE DISAPPEARED TO A BLIND SPOT IN THE CAMERA COVERAGE NEAR THE BACK OF THE STORE, BEFORE WAITING FOR OFFICERS TO ENTER IN THE MIDDLE OF THE STORE, MR. PARK STATED THE DAMAGE TO THE WINDOW WAS FRESH, AND THAT THE PHONE THERE WAS NOT HIS OR HIS WIFE'S. OFFICERS COLLECTED THE PHONE AND IN DOING SO OBSERVED THAT THE SCREEN SAVER WAS MR. COURTNEY AND THE FLASH LIGHT ON THE PHONE WAS ON. OFFICERS NOTIFIED MAJOR CRIMES DETECTIVES AND THE ON DUTY SUPERVISOR. WHEN ASKED, MR. PARK STATED HE DID NOT WANT TO PRESS CHARGES, AS HE KNOWS MR. COURTNEY TO LIVE IN THE IMMEDIATE AREA, AND THAT EVEN IF HE WERE TO GO TO JAIL HE WOULD COME BACK SHORTLY THERE AFTER AND HE DID NOT WANT THINGS TO ESCALATE OR BECOME MORE DANGEROUS. MR. PARK REQUESTED THAT MR. COURTNEY BE INFORMED HE CAN NO LONGER BE A CUSTOMER AT THIS BUSINESS. MR. COURTNEY STATED HE UNDERSTOOD. THE STOLEN PROPERTY LOCATED ON MR. COURTNEY WAS RETURNED TO MR. PARK AND MR. COURTNEY WAS TRANSPORTED HOME. MVR AND BWC IN USE.
