## Public Safety Commission Meeting - 11/20/2025

### **I. Roll Call**

**Commissioner Moffitt reported on MDA involvement with Everytown and shared that a Project HEAL grant was approved for \$100,000. She also noted that Chief Helton is excited about the GVI rollout.**

- Motion by Morshedi to revise the CSU letter by removing the paragraph urging action and replacing it with a request for support in escalating the issue. Seconded by Commissioner Burris.
