NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A BATTERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. LAWRENCE OLIVER WHO ADVISED HE WAS ATTACKED BY AN UNKNOWN BLACK MALE. LAWRENCE ADVISED HE HAD MADE FOOD FOR THE RESIDENTS LIVING IN APARTMENTS 1-12 AT THE LOCATION USING BORROWED COOKWARE. LAWRENCE ADVISED HE HAD A TABLE SET UP OUTSIDE HIS APARTMENT. LAWRENCE ADVISED HE WAS APPROACHED BY AN UNKNOWN BLACK MALE WHO WANTED SOME OF THE FOOD. LAWRENCE ADVISED HIM HE COULD NOT HAVE THE FOOD. LAWRENCE ADVISED HE DID NOT RECOGNIZE THE UNKNOWN SUSPECT. LAWRENCE ADVISED HE WENT BACK INTO HIS ROOM.

LAWRENCE ADVISED THE UNKNOWN SUSPECT FOLLOWED HIM INTO HIS ROOM. LAWRENCE ADVISED THE UNKNOWN SUSPECT SHUT THE DOOR BEHIND HIM AND BEGAN THREATENING TO BLOW LAWRENCE'S HEAD OFF. LAWRENCE ADVISED THE UNKNOWN SUSPECT POSTURED AS IF HE HAD A FIREARM INSIDE HIS JACKET. LAWRENCE ADVISED HE DID NOT POSITIVELY SEE A FIREARM.

LAWRENCE ADVISED THE UNKNOWN SUSPECT BEGAN TO BATTER LAWRENCE BY PUNCHING HIM IN THE HEAD. LAWRENCE ADVISED HE PUSHED THE SUSPECT OUT OF HIS ROOM. LAWRENCE ADVISED THE UNKNOWN SUSPECT STOLE SOME OF THE COOKWARE FROM THE TABLE IN THE HALLWAY. LAWRENCE ADVISED HE BELIEVED THE UNKNOWN SUSPECT FLED ON FOOT TO ROOM 5.

OFFICERS MADE CONTACT WITH EMPLOYEES AT THE LOCATION WHO ADVISED THEY HAD CAMERA FOOTAGE. EMPLOYEES AT THE LOCATION ADVISED THE SUSPECT WAS NOT A RESIDENT AND DID NOT RECOGNIZE THEM. OFFICERS OBSERVED CAMERA FOOTAGE OF THE INCIDENT PROVIDED BY EMPLOYEES. OFFICERS OBSERVED THE FOOTAGE DISPLAYED THE UNKNOWN SUSPECT AND LAWRENCE ENTERING A VERBAL ALTERCATION OUTSIDE OF ROOM 2 AT APPROXIMATELY 1840 HOURS.

OFFICERS OBSERVED LAWRENCE ENTERING ROOM 2. OFFICERS OBSERVED THE UNKNOWN SUSPECT LINGERING AT THE DOORWAY FOR A BRIEF MOMENT BEFORE ENTERING ROOM 2. OFFICERS OBSERVED THE UNKNOWN SUSPECT SHUT THE DOOR BEHIND HIM. OFFICERS OBSERVED THE SUSPECT BEING PUSHED OUT THE ROOM BY LAWRENCE.

OFFICERS OBSERVED THE UNKNOWN SUSPECT TAKING THE COOKWARE FROM THE TABLE OUTSIDE OF ROOM 2. OFFICERS OBSERVED THE UNKNOWN SUSPECT ENTERING ROOM 5 AT APPROXIMATELY 1853 HOURS. OFFICERS ATTEMPTED TO MAKE CONTACT WITH THE UNKNOWN SUSPECT AT ROOM 5. RESIDENTS OF ROOM 5 DID OPEN THE DOOR AND CONSENT FOR OFFICERS TO SEARCH THE RESIDENCE FOR THE UNKNOWN SUSPECT. OFFICERS OBTAINED NEGATIVE RESULTS IN LOCATING THE SUSPECT IN ROOM 5. RESIDENTS OF ROOM 5 STATED THEY BELIEVED THE MAN TO BE "J.W." BUT DID NOT KNOW HIS FULL NAME. RESIDENTS IN ROOM 5 STATED THEY BELIEVE J.W. TO BE HOMELESS. RESIDENTS IN ROOM 5 STATED THEY ONLY KNOW J.W. AS HE WANDERS AROUND THE AREA OF THE ELM STREET COMMUNITY CENTER.

OFFICERS DID NOT OBSERVE ANY PHYSICAL INJURY TO LAWRENCE. OFFICERS DID NOT OBSERVE A BATTERY ON CAMERA FOOTAGE. LAWRENCE ADVISED HE BEGAN FEELING DIZZY. OFFICERS CALLED FOR MEMS. MEMS ARRIVED AND ASSESSED LAWRENCE.

LAWRENCE ADVISED HE DID NOT WISH TO GO TO THE HOSPITAL. MEMS LEFT THE SCENE. MAJOR CRIMES DETECTIVES WERE NOTIFIED. MAJOR CRIMES DETECTIVES ADVISED IF A SUSPECT WAS IN CUSTODY AND LAWRENCE WISHED TO BE INTERVIEWED AT THE 12TH STREET SUBSTATION TO HAVE THEM TRANSPORTED ACCORDINGLY. OFFICERS COULD NOT LOCATE THE UNKNOWN SUSPECT. LAWRENCE ADVISED HE DID NOT WISH TO BE TRANSPORTED TO THE 12TH STREET SUBSTATION.

OFFICERS PROVIDED LAWRENCE AND EMPLOYEES AT THE LOCATION AN INCIDENT CARD AND ADVISED THEM TO CONTACT POLICE IF ANY FURTHER CONTACT WAS NECESSARY OR IF ANY FURTHER INFORMATION COULD BE PROVIDED. OFFICERS DID NOT CONDUCT A BROADCAST FOR THE SUSPECT DUE TO LIMITED AND VAGUE INFORMATION. OFFICERS LEFT THE SCENE WITHOUT INCIDENT. BODY WORN CAMERA AND MOTOR VEHICLE RECORDING IN USE.
