NARRATIVE

ON 12/16/2025, OFFICERS WERE DISPATCHED TO ABOVE LOCATION FOR A ROBBERY INVOLVING A KNIFE. OFFICERS ARRIVED ON SCENE AND DID NOT FIND ANYONE ON SCENE. WHILE ON SCENE, OFFICERS GOT A CALL FROM MS. CLARK WHO STATED THAT SHE IS GOING TO KILL HERSELF BECAUSE THE MAN (MR. LEWIS) WHO TRIED TO ROB HER BOYFRIEND (MR. FARRAKHAM). THE WOMAN WAS AT 200 S SHACKLEFORD RD, ROOM 219. OFFICERS WENT TO THE ADDRESS AND LOCATED MR. FARRAKHAM AND MS. CLARK. MR. FARRALHAM STATED THAT HIM AND MR. LEWIS DID SOME TRADING ON SOME SHOES. MR. FARRALHAM STATED THAT MR. LEWIS WANTED TO KEEP ONE PAIR OF SHOES BUT THEN DEMANDED THAT HE GIVE HIM THE PAIR HE WAS WEARING. MR. FARRALHAM TOLD MR. LEWIS THAT HE WAS NOT GOING TO GIVE HIM HIS SHOES. MR. FARRALHAM STATED THAT MR. LEWIS GOT MAD AND PULLED A KNIFE ON HIM, DEMANDING THE SHOES. MR. FARRALHAM TOLD HIM NO AND THEN MR. LEWIS DECIDED TO WALK AWAY, STATING HE WILL GET THEM ANOTHER DAY. MS. CLARK STATED THAT SHE WAS NO SUICIDAL. MEMS CHECKED MS. CLARK OUT AND SHE REFUSED TO GO TO THE HOSPITAL. MVR/BWC WERE USED.
