## **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A CUTTING. OFFICERS MADE CONTACT WITH THE CALLER DAMIEN GRANBERRY. MR. GRANBERRY ADVISED HE WAS IN HIS ENCAMPMENT IN THE WOODS NEAR THE INTERSECTION OF 28TH ST AND BOYD ST. MR. GRANBERRY ADVISED AN UNKNOWN BLACK MALE AND AN UNKNOWN BLACK, POSSIBLY HISPANIC, FEMALE APPROACHED HIS CAMP DEMANDING PROPERTY THEY CLAIM HIS SON STOLE FROM THEM. MR. GRANBERRY ADVISED HE DID NOT HAVE A SON AND DID NOT HAVE PROPERTY BELONGING TO THEM. MR. GRANBERRY ADVISED THEY BOTH THREATENED TO SHOOT HIM MULTIPLE TIMES WHILE ON SCENE.

MR. GRANBERRY ADVISED THE BLACK MALE AND FEMALE CAME INTO HIS CAMP. MR. GRANBERRY ADVISED THE BLACK FEMALE BEGAN RIFLING THROUGH HIS BELONGINGS AND REMOVING HIS ELECTRONICS. MR. GRANBERRY ADVISED HE "LUNGED" AT THE BLACK FEMALE AND STABBED HER WITH HIS SMALL BLACK AND RED KNIFE. MR. GRANBERRY ADVISED BOTH SUSPECTS IMMEDIATELY RETREATED SOUTH BOUND TOWARD 28TH ST AFTER THE FEMALE HAD BEEN STABBED.

OFFICERS CANVASSED THE AREA OF 28TH AN BOYD WITH NEGATIVE RESULTS FOR SUSPECTS MATCHING THE GIVEN DESCRIPTION. OFFICERS SEARCHED THE CAMP SITE AND LOCATED THE KNIFE MR. GRANBERRY USED. OFFICERS ALSO LOCATED A BLACK HAT WHICH, MR. GRANBERRY ADVISED, BELONGED TO THE MALE SUSPECT. MR. GRANBERRY ADVISED THE FEMALE WAS LIGHTER SKINNED, SHORTER AND WAS HEAVIER IN WEIGHT WITH UNKNOWN CLOTHING. MR. GRANBERRY ADVISED THE MALE WAS MEDIUM TO DARK SKINNED, TALL, SKINNY, WITH GLASSES AND UNKNOWN CLOTHING.

MR. GRANBERRY WAS NOT ASSAULTED DURING THIS ORDEAL. MR. GRANBERRY DECLINED MEDICAL. OFFICERS NOTIFIED SGT. CHIDESTER, WHO WAS ON SCENE. OFFICERS NOTIFIED MAJOR CRIMES. OFFICERS PROVIDED MR. GRANBERRY AN INCIDENT NUMBER. OFFICERS STORED THE BLACK HAT AND KNIFE AT THE NORTHWEST PROPERTY ROOM AS EVIDENCE. NO FURTHER ACTION WAS TAKEN. MVR AND BWC IN USE.
