NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A CALL OF A CUTTING JUST OCCURED.

OFFICERS MADE CONTACT WITH DELONTE NELSON, WHO HAD A SEVERE LACERATION ON HIS LEFT ARM. OFFICERS APPLIED A TOURNIQUET. NELSON WAS UNCOOPERATIVE WITH POLICE, PROVIDING A VAUGE DESCRIPTION OF A BLACK MALE, AND THEN CHANGING HIS STORY SEVERAL TIMES ABOUT WHERE THE CUTTING TOOK PLACE. OFFICERS WERE UNABLE TO LOCATE ANY BLOOD ON THE ENTIRE BLOCK WHERE NELSON CLAIMED THE CUTTING TOOK PLACE. NELSON ADVISED HE WAS SUDDENLY ATTACKED BY A MAN IN DARK CLOTHING WITH A MACHETTE.

ALSO ON SCENE WAS MISTY LAMB, WHO ADVISED THE SUSPECT WAS A WHITE MALE ON A BIKE. OFFICERS MDE CONTACT WITH SEVERAL SUBJECTS ON BIKES IN THE AREA.

NELSON ADVISED HE DID NOT WANT TO PRESS CHARGES. NELSON WAS TRANSPORTED BY MEMS. A MAJOR CRIMES DETECTIVE WAS NOTIFIED AND A SUPERVISOR RESPONDED TO THE SCENE.

TIDWELL ADVISED THAT HE THEN LEFT THE RESIDENCE AND CALLED 911 FROM THE DOLLAR GENERAL.
