

**INSTRUCTIONS FOR FILING A PETITION FOR  
ABANDONMENT OF A PUBLIC RIGHT-OF-WAY, STREET OR ALLEY**

1. The applicant/owner or authorized agent shall appear at the Department of Planning and Development, 723 West Markham, Little Rock, Arkansas; 371-4790, and complete the required application forms. These forms may be obtained in advance in order to expedite the filing.
2. The applicant shall submit as part of his/her application eighteen (18) copies of a survey or other instrument such as a recorded plat indicating the area of the street or alley involved.
3. Payment of a filing fee is required no later than the published docket closing date. Said fees are established by the City's adopted Fee Ordinance.
4. The applicant shall submit as part of the filing a letter from each of the five public utility companies stating their approval of the closure, or stating their request for needed easements including dimensions.
5. The applicant shall submit as part of his/her application a letter from an abstract company or equally reliable source which shall delineate the reversionary rights in the right-of-way and the source of dedication. The applicant must also submit a list of owners of all abutting properties as compiled and certified by an abstract company. The applicant shall submit a petition signed by all persons owning property which abuts the right-of-way to be abandoned.
6. Prior to acceptance of the petition, the owner is required to sign a statement dealing with dedication of required street rights-of-way on abutting streets. The applicant will be provided a form for this purpose which shall be completed by the owner indicating his/her position. The owner will be required at his or her expense to provide the proper legal instrument for such dedication. A blank form for this purpose may be obtained from the Planning Staff.
7. After filing the proper forms and meeting the requirements set forth above, the applicant shall give notice to affected properties as required below. Before the Planning Commission shall consider a petition for right-of-way, the petitioner shall first give at least 15 days written notice of the time, place and date of public hearing thereon to all record owners of land abutting portions of the street or alley involved. **THIS MEANS OWNERS OF PROPERTY WHICH ABUTS ANY PORTION OF THE RIGHT-OF-WAY TO BE CLOSED, INCLUDING OWNERS AT EACH END OF THE AFFECTED RIGHT-OF-WAY.** The notification shall be by certified mail. The form for notice shall be that as provided by the staff.
8. An affidavit is required stating the owner has complied as directed on the notice requirement. The affidavit shall be accompanied by a copy of the notice mailed and the postal receipts for mailing. A return receipt is not required. This proof of notice shall be filed with the staff at least six (6) days prior to the Planning Commission meeting.
9. The applicant should be present at the meeting in order to answer any questions of the Commission or other interested parties. The absence of the applicant may be cause for deferral.
10. The applicant's noncompliance with the above may cause the petition to be withheld or not considered at the meeting scheduled and may require the renotification of property owners.
